***Dristikon: Multidisciplinary Peer Review Journal*** (ISSN 2382-5456) is a multidisciplinary double-blind peer-reviewed academic research journal of the Research Management Cell, Mahendra Multiple Campus, Dharan. The basic objective of the Journal is to disseminate expertise knowledge based on research relevant to academics and practicing field. It invites and accepts the innovative original academic or scholarly research-based papers, articles, and survey papers, case studies in multidisciplinary fields of research, development and application. Therefore, the contributor(s) must follow the following guidelines and the contributions that do not follow the terms & conditions and guidelines will not be entertained for the process of publication.

### **Scope of the Journal**

*Dristikon* is a multidisciplinary double blind peer-reviewed academic research journal. It aims to publish research work of the academics and practitioners so as to create an interdisciplinary forum for the dissemination of novel, significant and original research results from the following disciplines:

### **Terms and Conditions**

1. The papers will be selected for publication based on the relevance, clarity, originality, topicality.
2. The publications of papers are selected through peer reviewed process to ensure originality, relevance, and readability.
3. The basic guiding principle for the peer review process of the DRIDHTIKON Multi-disciplinary Peer Reviewed Journal (ISSN: 2382-5456) is based on the guidelines prepared by the University Grants Commission Nepal as well editorial board of RMC.
4. Two copies of manuscript, one in editable word file and the other in PDF format, are to be prepared and submitted to the Secretary/ Editor-in-Chief, RMC in the form of hard and soft copy. However, the contributor of other places may send only softcopy in the prescribed email. The files should include text, references, tables and figures.
5. The submissions are subject to editorial scrutiny and necessary change.
6. The first page of the manuscript should include the title, author(s), authors' affiliation, post, ORCID No. (if any) and email address for correspondence purpose.
7. Figures or photographs must be presented in jpg files.
8. The tables and equations should be in an editable rather than image version, i.e. Tables by Word/ Excel and equations by Equation Editor.
9. Tables and Figures and Equations should be numbered as Table 1, Table 2 ...; Figure 1, Figure 2, Figure 3... etc. in sequential order in the flow of the text.
10. The preferred fonts for the manuscript are Times New Roman and Preeti, 12/14 pt. (for Nepali) point size and typed within 1 inch margin each side.
11. APA Publication Manual of APA (7th ed.) is the standard format of the papers.
12. The author(s) must ensure and declare that the article is original, novel and free from any kind of plagiarism and it has not been previously published and considered for publication elsewhere.
13. The manuscript will not be published unless duly original signed copyright and declaration form either as hard copy or scanned has been received from the contributor(s).
14. The author(s) must state that all data used in the paper are real and authentic.
15. Authors should provide all sources of data used in the article.

16. It is the responsibility of the author(s) to edit the articles as suggested by reviewers and the Editorials Board.
17. Authors should provide revised version of their article, according to the reviewers' recommendations and ultimate responsibility for any error goes to authors themselves.
18. For any dispute regarding the selection of the manuscript for publication, the decision of the editorial board will be final.

### **Review Processes**

1. The manuscript submitted for the publication purpose with necessary documents (including cover letter, author's declaration) will be first checked by the Editorial Board for suitability of the paper and by the anti-plagiarism software.
2. Only the manuscript accepted by reviewer(s) will be considered for the publication process.
3. The articles rejected by reviewers will not be resent for further review process.
4. If the manuscript is rejected by any one of the reviewers and accepted by the other one, the decision of the Editorial Board will be final to decide.

### **Plagiarism Policy**

1. The journal considers plagiarism as a serious act of violation of research ethics.
2. If any plagiarism is found before and after the acceptance or publication, the article will be withdrawn and the author(s) will also be black-listed for publishing papers for a period determined by the Editorial Board. However, the author will be given a chance for explanation.

### ***The authors should note that:***

1. Articles must be written in English, Nepali, and Sanskrit.
2. Articles submitted must be the original work of the author(s) listed, and not previously published in part or full anywhere.
3. An article must have a minimum of 4,000 words, but should not exceed 7,000 words. The text or paragraphs should be left justified only with a paragraph space.
4. Articles should be consistent in style throughout, especially if different authors have contributed sections. All submissions are expected to contain scholarly citations, including layout formats of APA style, 7th ed.
5. The following components should be included in all articles:
  - Title
  - Author's information (name, position, university, affiliation, address, email/gmail address, Mob. No., recent passport size photo)

- Abstract (within the range of 150 to 250 words)
- Keywords: 5-7 words or phrases
- Main Headings (sub-headings are optional) include:
  - I. Introduction.** Background, Focus, Problem Statement, Research Objectives, Hypothesis (if any) Significance of the Study, Framework, Literature Review.
  - II. Materials and Methods.** Populations & Sample- Nature, Source; Data- Nature, Source, Types, Methods, Tools, Techniques; Research Limitations, Delimitations.
  - III. Results and Discussion.** With major point wise findings and
  - Conclusion**
  - Implications** (Optional)
  - Acknowledgements** (Optional)
  - References.** As per APA styles 7th ed. with one and half lining space and with 2nd line & other indented.

6. The name of the author should not appear in any part of the text.
7. The author will be responsible for any grammatical error in the paper and will make correction from English language expert.
8. All submissions will be assessed by double blind reviewing process to determine whether they fall within the nature of our journal and meet our requirements.
